At a regular second meeting of the Board of Education at Old Village School, 405 W. Main, Northville, Michigan, the Board took the following action:

- The Board approved the following consent agenda items: Minutes of the 08/14/07 Regular Meeting of the Board of Education; and field trip request from Hillside Middle School to go to Washington, D.C. on May 24-26, 2008.
- Superintendent and members of Cabinet updated the Board on the 2007/08 Start of School Year plans and that all school buildings are cleaned and ready to go for the start of the new school year.
- The Board approved the following new certified teacher hires: David Clark, Joanne Jackson, Elizabeth Johnson, Maria Kraska, Jeremy Lingenfelter, Michelle Riggs, Nicole Scaglione, Candace Stafiej, and Cherilyn Watkins.
- The 2006/07 Year-End Report was presented to the Board of Education. Each cabinet member reported on their respective department's accomplishments, issue, challenges and concerns for the past school year. Copies of this report are available in the superintendent's office for any interested citizen.
- The Board accepted administration's recommendation to exercise the opt-out provision of the School Breakfast Program, Section 30.1272, Michigan School Code for the 2007/08 school year.
- The Board approved the MASB Certification of Delegates and Alternates to represent the Northville Public Schools at the MASB Delegate Assembly in Grand Rapids on Thursday, November 1, 2007 at 7:00 p.m.
- The Board approved the following teacher recall for the 2007/08 school year: Allison Brumo, Kim Callison, Catherine Gibson, Josh McGowan, Kristin Miler, and Christine Parnin.
- Citizen Ben Stanley expressed his appreciation of the additional sections in lower elementary classes; however, he registered his concern about the high numbers in the upper elementary grades. He asked if Teacher Assistants can be hired to help with those high numbers. Mr. Stanley also addressed the Board about boundaries. If the growth at Ridge Wood and Moraine decline, he is suggesting that boundaries be revisited so class size and enrollment is more equitable across the district.
- The Board recessed into Executive Session for the purposes of negotiations.
